2023 – 2024 STUDENT FINANCIAL AGREEMENT

THIS AGREEMENT dated _____ by and between Mount Michael Benedictine School and _____ (Parent/Guardian and also “Enroller”) for _____ (Student) who graduates in the year _____.

- a DAY student.
- a FIVE DAY RESIDENTIAL student.
- a SEVEN DAY RESIDENTIAL student. (if approved).

Enroller agrees to pay all tuition, room and board, and fees for the academic year 2023 – 2024 for Student. Mount Michael Benedictine School agrees to reserve a place at Mount Michael Benedictine School for the academic year 2023 – 2024 upon receipt of the Registration Fee.

TUITION/ROOM AND BOARD/FEES PAYMENT PLANS:

- ❖ Annual Payment in full no later than July 5, 2023
- ❖ Semester Two equal payments: July 2023 and January 2024
Payment is expected by the 20th of the month.
- ❖ Quarterly Four payments: July 2023, October 2023, January 2024, April 2024
Payment is expected by the 20th of the month.
- ❖ Monthly [Option 1] 12 Monthly payments beginning May 2023 through April 2024
- ❖ Monthly [Option 2] 10 Monthly payments beginning July 2023 through April 2024

Enroller has elected to pay tuition/room and board/fees according to the following payment plan: (check one)

- Annual (paid directly to Mount Michael Benedictine School)
 - Semester (plus \$15* one-time processing fee through Facts Tuition Management)
 - Quarterly (plus \$50* one-time processing fee through Facts Tuition Management)
 - Monthly [Option 1] (plus \$50* one-time processing fee through Facts Tuition Management)
 - Monthly [Option 2] (plus \$50* one-time processing fee through Facts Tuition Management)

Enroller agrees to pay Mount Michael Benedictine School the Registration Fee by **February 17, 2023**. (Freshman financial agreements are due on February 28, 2023.) **THE REGISTRATION FEE IS NONREFUNDABLE.**

The Enroller will be responsible for any extraordinary damages to rooms/lockers beyond what is normally expected. Extraordinary damages to rooms/lockers will be billed and due as incurred.

TIMELINESS OF PAYMENTS: STUDENTS WILL NOT BE ADMITTED TO CLASSES UNTIL THE PAYMENT IS RECEIVED ACCORDING TO THE PAYMENT SCHEDULE SELECTED. MOUNT MICHAEL BENEDICTINE SCHOOL RESERVES THE RIGHT TO REQUIRE THE WITHDRAWAL OF ANY STUDENT IF PAYMENTS ARE NOT MADE ACCORDING TO THE SELECTED SCHEDULE.

ENROLLER AFFIRMS THAT STUDENT HAS NOT BEEN DIAGNOSED WITH ANY COGNITIVE OR DEVELOPMENTAL IMPAIRMENTS WHICH WOULD REQUIRE MOUNT MICHAEL BENEDICTINE SCHOOL TO MAKE ANY SPECIAL ACCOMODATIONS, EXCEPT AS DISCLOSED IN A SEPARATE SHEET OF PAPER ATTACHED TO THIS AGREEMENT. IF ENROLLER FAILS TO DISCLOSE ANY KNOWN COGNITIVE OR DEVELOPMENTAL IMPAIRMENTS OF STUDENT, MOUNT MICHAEL RESERVES THE RIGHT TO REQUIRE THE WITHDRAWAL OF STUDENT.

ENROLLER UNDERSTANDS THAT MOUNT MICHAEL BENEDICTINE SCHOOL REQUIRES FULL-TIME (MONDAY-FRIDAY) ATTENDANCE. IF STUDENT IS UNABLE TO ATTEND MOUNT MICHAEL ON A FULL-TIME BASIS, MOUNT MICHAEL BENEDICTINE SCHOOL RESERVES THE RIGHT TO REQUIRE THE WITHDRAWAL OF STUDENT.

STUDENT CANCELLATION: Enroller must cancel the Student's enrollment in writing. Notification must be received on or before July 15, 2023.

WITHDRAWAL: After July 15, this tuition, room and board, and fee agreement applies to the entire academic year and obligates Enroller to pay the entire academic year's tuition, room and board, and fees, whether or not the Student completes the school year. Mount Michael Benedictine School also expressly reserves the right to require the withdrawal of any student for unsatisfactory academic performance or any disciplinary infraction specified in the Mount Michael Benedictine School Student Handbook, the terms of which are expressly incorporated by reference in this Agreement.

THIS AGREEMENT SUPERCEDES ANY AND ALL PRIOR CONTEMPORANEOUS ORAL UNDERSTANDINGS RELATING TO THIS SUBJECT MATTER. THIS AGREEMENT SHALL BE INTERPRETED IN ACCORDANCE WITH NEBRASKA LAW.
